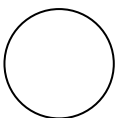

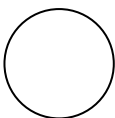

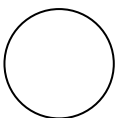


CONDITION FOR CREDIT FACILITIES

I/we as the Applicant for an account referred to on the face of this form hereby apply to Protector Aluminium Pty Ltd for a trading account. The following terms & conditions shall apply to all sales made by Protector Aluminium Pty Ltd to the Applicant.

I/we as the Applicant acknowledge that in the event of this application being accepted:

1. Payments for all purchases must be made within thirty (30) days from End of Month.
 2. Any Payments outstanding after thirty days may attract an administration charge at the rate of five percent (5%) per month on total of the invoice.
 3. All accounts 2 weeks overdue will automatically be placed on stop credit. All accounts 4 weeks overdue will automatically be referred to a collection agency and the applicants account will instantly incur a ten percent (10%) late payment fee and all associated collection fees will be payable by the applicant.
 4. All Credit card payments will incur a 2% payment fee.
 5. The Applicant acknowledges that the Credit Facility and Account number provided to the Applicant are personal to the Applicant and shall not be assigned, transferred or made available by the Applicant for use by any other corporation, person or organization and further acknowledges that any goods ordered/purchased or services rendered under the Credit Facility or Account number shall be paid by the Applicant.
 6. Title to and property in any goods supplied and delivered by Protector Aluminium Pty Ltd to the Applicant shall not pass until such goods have been paid for in full and any cheques presented by the applicant for payment have been cleared.
 7. Goods shall be at the Applicants risk from the date of delivery.
 8. It is the Applicant's responsibility to notify Protector Aluminium of any or any intended change in the corporate structure, shareholding or management by written notice 30 days of such event occurring.
 9. That Protector Aluminium, may at any time without notice terminate or suspend the Applicant's right to purchase goods and obtain services upon credit.
 10. In the event of the Applicant failing to pay for goods within the time prescribed, being declared bankrupt, having a receiver appointed, being placed in liquidation or entering into a scheme of arrangement with creditors, Protector Aluminium Pty Ltd and/or its agents or servants is hereby authorized to enter upon the Applicant's premises and retake possession on any goods sold by Protector Aluminium Pty Ltd to the Applicant for which payment in full has not been made. Protector Aluminium Pty Ltd shall be entitled to appropriate or dispose of these goods as it sees fit.
 11. The terms of this Agreement are continuing and apply to all subsequent sales by Protector Aluminium Pty Ltd to the Applicant.
 12. All Payments are due and payable to Protector Aluminium Pty Ltd.
- 12.1 Charge in land: By executing this Credit application, the Applicant and if the Applicant is a company, each of the Directors of the Applicant ("the directors"), hereby create an interest in land and charge in favor of the Protector Aluminium Pty Ltd ("the business") and each/all of the owners of the business in respect of all real estate, land and buildings owned by the Applicant or the Directors of the Applicant.

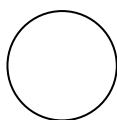

- 12.2 Caveat: To better secure the interest in land and charge given by clause 8.1, the Applicant and the Directors consent to the business and/or each/all of the owners of the business lodging and registering a caveat on the titles of each piece or parcel of land owned by the Applicant and each piece or parcel of land owned by the Directors or any of them.

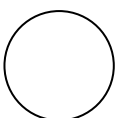
